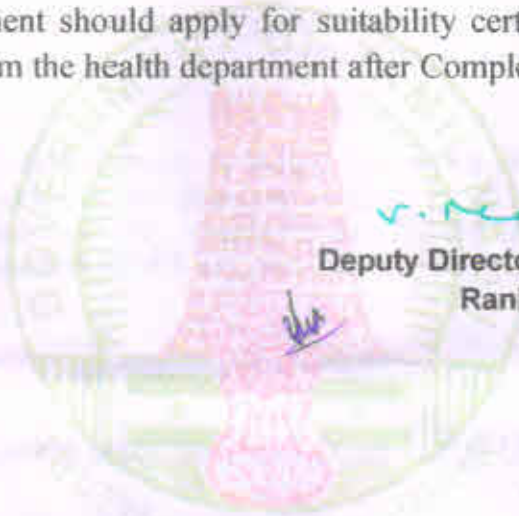
Based on the Inspection report of Block Health Supervisor, GPHC,

- Protected water supply should be supplied to be wholesome.
- All the conditions laid down by the fire service department should be

- The institution should ban the cigarette and other Tobacco products in the campus and visible board to be displayed - COTP Act 2003.
- The Institution should ban the use and throw plastic in practice in the campus
- Suitable size of Rainwater Harvesting to be constructed
- Any episode of communicable diseases to be informed immediately to the Health Authority safety of food and drink in food establishments to be maintained strictly.
- The catering establishment employees to be examined medically one in six month and they should free from contagious diseases.
- All the statutory should be strictly adhered
- Any violation of this act leads to cancellation of this order.

- The management should apply for suitability certificate for Occupation Certificate from the health department after Completion of Construction.
