71A) Y	The total number of sections of Bal Vatika shall be restricted to 03 (1 sections each in Bal Vatika I, II & III respectively). The total number of sections from classes I to X shall be restricted to 12. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of >500 sq. ft. dimension.
2	The school shall install doors/half doors in the separated toilet cubicles to ensure privacy, within 3months and submit compliance on SARAS with videography.
