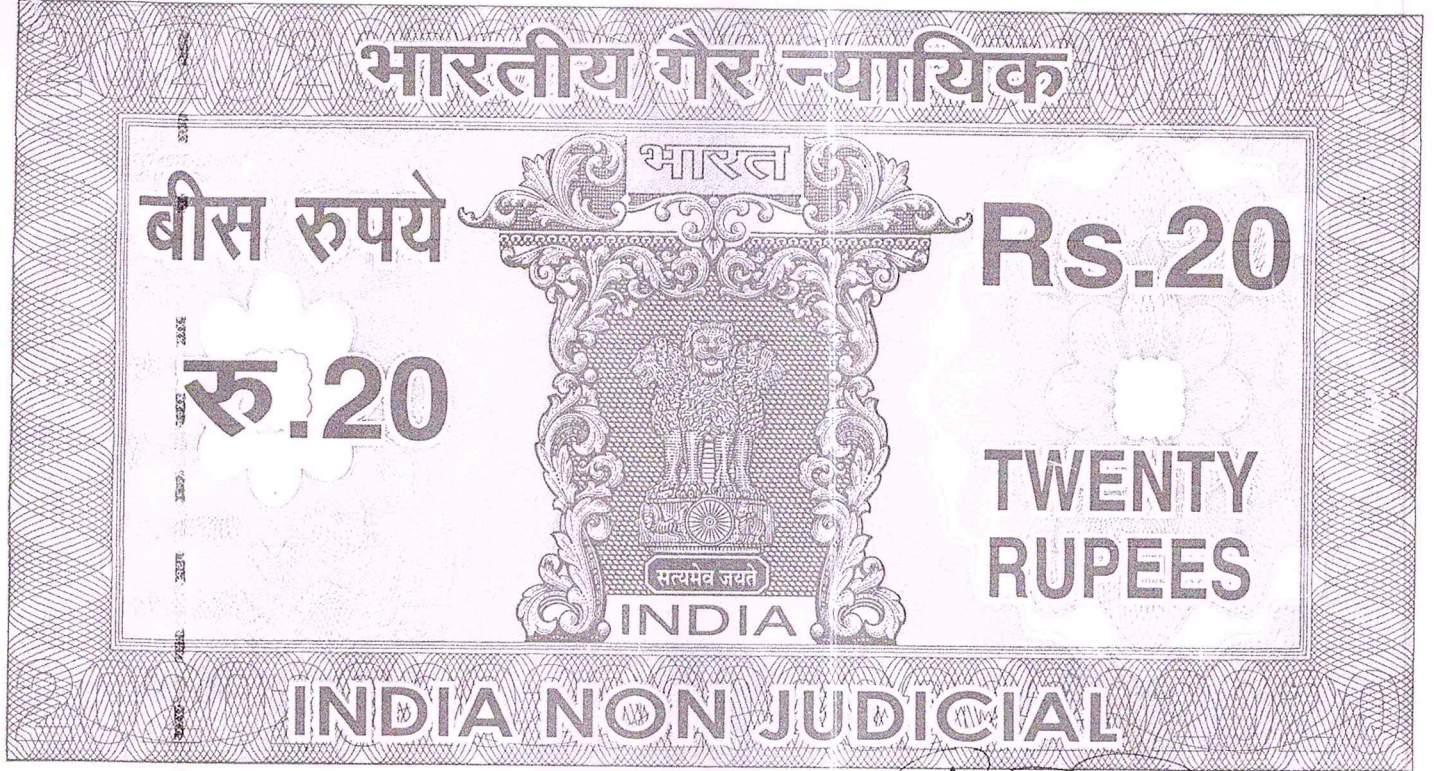

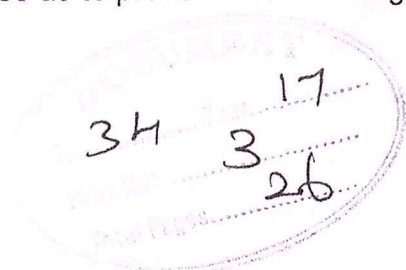

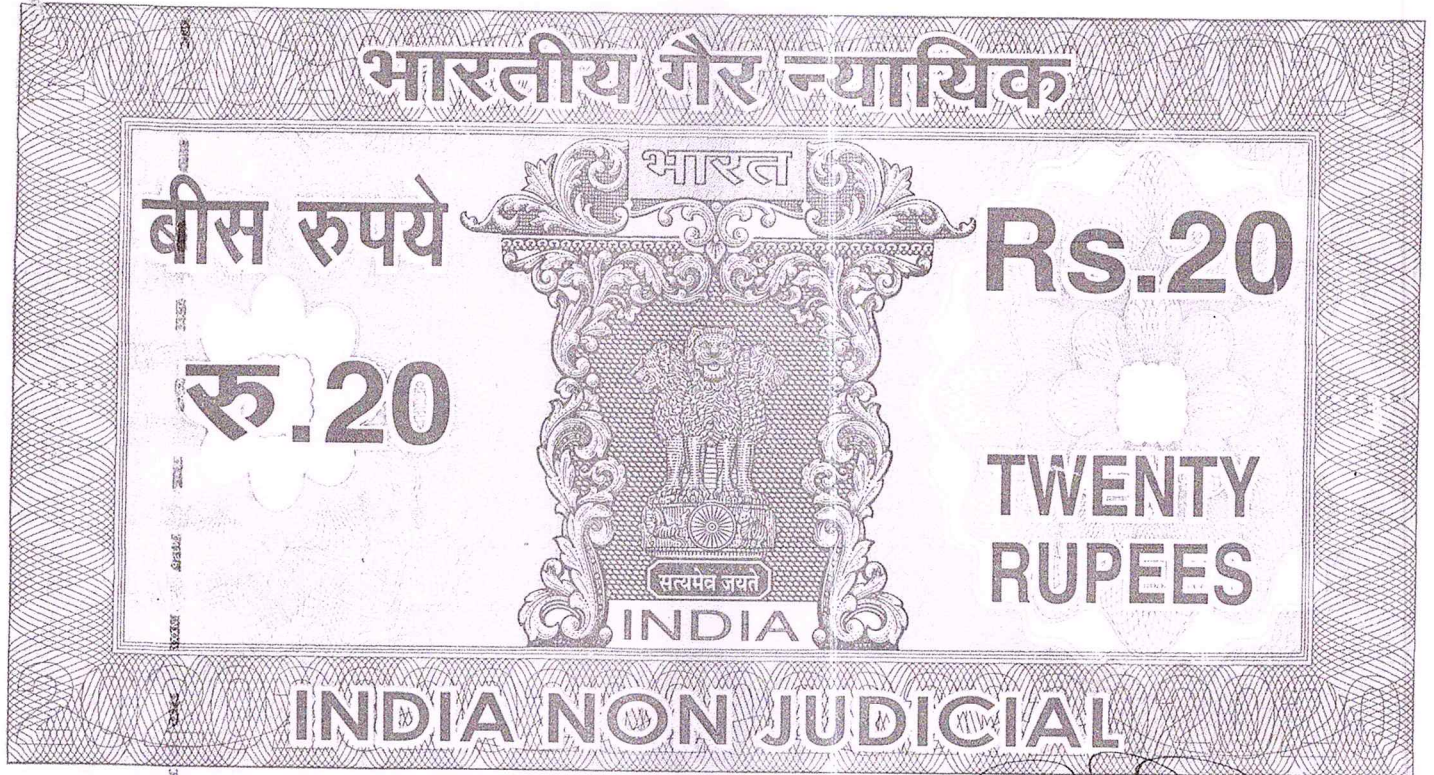

Notice calling for Board meeting shall be sent to all trustees at least 3 weeks in advance specifying the agenda for the meeting. Board meeting shall be called for even at a shorter notice with the consent of all the members. #### XIV) AMENDMENT :

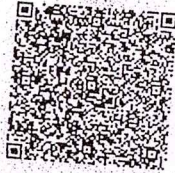

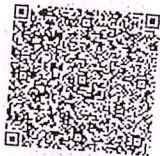

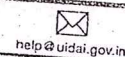
